1. Welcome and agenda

Quorum: 23 votes (= 1/3 of the Board members; Art. 24.1 Statutes); Votes present: 25 present + 3 proxies + 7 electronic vote = 35 → The quorum is reached.

The Chair asks for comments concerning the minutes of the previous meeting. Since there are none, the Chair invites the Board to approve them. The minutes are approved and will be published on the CHIPP website.

DECISION ITEMS

4. Closure of the 2021 Accounts

The Chair reminds that CHIPP, as member of SCNAT, has to deliver an annual report to this

organization and that therefore the format of the CHIPP annual activity report is based on the SCNAT format. The very first draft of the annual report is available on the reserved CHIPP directory. Angela asks the Board members to please check the entries of their own Institute regarding CHIPP members acting as official delegates to international organisations, if there were changes with respect to 2020. It will be possible to update the document until 20 March. Please send input to Angela.

Annual Accounts 2020

Angela briefly presents the main income and expenditures of the profit and loss statements. The incomes amount to 151'763.- CHF and the expenses to 153'605.- CHF, resulting in a loss of 1'842.- CHF. This is reflected in the balance sheet by a corresponding decrease in assets from 39'550 CHF at the end of 2020 to 37'708 CHF at the end of 2021. Angela and Susanne Hodler performed the accounts independently. They were in full agreement, and the documents presented to the auditors were the ones of Ms. Hodler.

• Auditor's Report

The audit took place on the 15 February 2022 via ZOOM with two auditors – Saverio Braccini (Uni Bern) & Steven Schramm (UniGe) – in the presence of Angela Benelli (administrator), and Susanne Hodler (accountant, SCNAT).

According to the auditors, the statements fairly represent the financial position of CHIPP, have been prepared with care and comply with statutory requirements.

The Board unanimously:

- approves the CHIPP Annual Report 2021 to be made publicly accessible on the CHIPP website;
- approves the annual accounts, the balance sheet, and the profit and loss statement for 2021;
- formally discharges the CHIPP EB and the CHIPP administration for the year 2021, expressing at the same time its thanks and appreciation for the careful accounting.

DISCUSSION ITEMS

5. FLARE Table update

Michele Weber reminds the Board of the new FLARE call in 2022. This call is part of the 2021-2024 FLARE period. There was a first call in 2020 with the possibility to submit two, three or four years and there is now a new call with a deadline of 15th of November of this year to cover grants for 2023 and 2024.

In 2020 CHIPP prepared a <u>prioritization document</u> where we indicated three categories of projects: uncuttable, flagship and fair share programs. CHIPP will keep the same structure and the basics of this prioritization document for the full 4-year FLARE period, but we can re-evaluate it and make minor modifications in view of the submission at the end of this year for the part concerning the fair share project requests. The EB proposes to initiate a process of updates for the FLARE tables to be handed in by the 18th March; in particular, the updates are requested regarding the 23-24 years and more precise estimations regarding the 25-28 period. The CHIPP roadmap for particle physics is the Swiss input to the next FLARE period. The discussion of the updates will take place in June at the CHIPP Board, while the presentation of the planned submissions will take place at the Fall CHIPP Board.

6. CHIPP functions and tasks – call for nomination

Several CHIPP positions need to be renewed next year; the EB follows the common practice: if a person wishes to continue for a 2nd term, we do not call for nominations, and there will be a re-election by the Board; If a term beyond second is aimed for, we call for nomination and there will be an election by the Board.

The EB reports on the decision that Ben Kilminster has been appointed as DUNE and HyperK RRB delegate. SERI has been informed and agrees on this decision.

S. Schramm is leading the input from the ET computing side. P. Jetzer (CHAPS) and S. Schramm agreed to be the representatives of the CHIPP/CHAPS GW group for now.

8. CHIPP Prize 2022

Gino Isidori asks the Board to encourage students to apply; the deadline is 1 April 2022. The winner announcement will be made at the CHIPP plenary meeting in June; the presentation will be arranged at the SPS Annual meeting.

9. CHIPP Plenary meeting

This year the CHIPP Annual meeting will be held, together with the SPS at the University of Fribourg from the 27th June to the 1st July 2022.

The EB is organising together with the ERC forum group the Plenary meeting and some satellite events reserved for the ERC group. The best solution is to have both the CHIPP Board and Plenary meetings on the first day of the SPS meeting, the 27th June. We decided to organise a buffet lunch reserved for CHIPP members and to have (maybe) an outing in the evening together with the ERC group.

10. FCC status & updates in Switzerland

Anna Sfyrla gives an update on the FCC workshop; it will be organized in May. Physics and detector strategy/requests will be discussed. It will be a privileged place where CHIPP can discuss input from institutes of Interest and activities.

Feasibility studies MoU are updated and more concrete:

- The University of Bern signed the MoU.
- The University of Basel is in the process of signing the MoU with S. Antusch's group being active on theory aspects such as Heavy Neutral Leptons, and BSM in general.
