

- **12'221 User in 2017 (+421, +3.6% w.r.t. 2016)**
  - Member States: 7'151 (+193, +2.8% w.r.t. 2016)
  - Associate Member States: 478 (+248, +108% w.r.t. 2016)
  - Non-Member States: 4'592 (-20, -0.4% w.r.t. 2016)

- **927 Institutes\*** (+44, +5.0% w.r.t. 2016)
